

Safeguarding All in Sport

At the 2005 Annual General Meeting, the League introduced a Child Protection Policy and training for referees, players, officials and other volunteers that helps us to meet our legal obligations to develop a culture in which young people can participate in a safe and enjoyable environment. Over the years, the Legislation enforcing 'Child Protection' (now known as Safeguarding) has changed. Leading us to change the way we safeguard the league as a whole. New policies and procedures are now in place to address all our legal obligations.

Every year players, coaches, club officials and other volunteers derive great fun and satisfaction from belonging to sports clubs. As a voluntary organisation, Bury Rounders League has a duty not to harm or endanger anyone as a result of the activities it promotes.

Everyone who participates in the game of Rounders is entitled to do so in an enjoyable and safe environment and to be given the chance to experience the fun, challenge and sense of achievement that are inherent to sport. In addition, all participants are entitled to a duty of care and to be protected from abuse. We are committed to devising and implementing policies and procedures to ensure everyone in the sport accepts their responsibilities to safeguard all from harm and abuse. This means all teams provide a trained welfare officer (SPC1/SL1) to safeguard their team, and to report any concerns about their welfare.

The 'Bury Rounders Safeguarding Initiative (BRSI)' consists of several policies and procedures that have distributed to all Team Secretaries and Welfare Officers (TWO). It is important that individuals within your club/team are made aware of the existence of this document and are given ample opportunity to read it. By raising the profile of the policies in your club/team, you will be contributing to the proactive nature of Bury Rounders by contributing to our commitment to developing a culture in which young people can participate in a safe and enjoyable environment.

As part of this criterion, Bury Rounders has a nominated a "Welfare Team" whose responsibility is to:

- Promote the Bury Rounders Safeguarding Initiative
- Support the registration of all personnel involved in your club;
- Receive, record and pass on to the person any concerns relating to the welfare of young people within your club;
- Liaise with the Welfare Co-ordinator.
- To hold a valid Safeguarding Certificate
